

Day 1 (Wednesday, 5/18) - Depart USA

Day 2 (Thursday, 5/19) - Arrive in Rome

Enjoy a panoramic drive from the airport through Rome and the countryside to the port at Civitavecchia to board the Celebrity Equinox. We will gather after dinner to get to know one another and begin our time of learning and fellowship – cocktails included!

Day 3 (Friday, 5/20) - Amalfi Coast

Today is yours to rest aboard ship, connect with new and long-time friends, or select one of the many shore excursions offered by the cruise line (excursions not included on this day). As the sun sets will usher in Shabbat with a delicious dinner and Services.

Day 4 (Saturday, 5/21) - At Sea

We will meet briefly to learn about the lives of Jews and Christians in the ancient Roman world, to lay a foundation for what we will see and experience in the coming days. We will have a Eucharist this evening.

Day 5 (Sunday, 5/22) - Athens and Corinth

In Roman times, Corinth had a large Jewish community and one of the earliest Christian communities. The city was a crossroads for people from all nearby cultures and languages. Our visit will give us the opportunity to consider the centuries-old challenges of faith and pluralism. We will continue our day in Athens first at the Acropolis with a stop at nearby Mars Hill, where Paul addressed the "Unknown God", then on to other important ancient sites as time permits.

Day 6 (Monday, 5/23) - Mykonos

Today is yours to rest aboard ship or select one of the shore excursions offered by the cruise line (excursions not included on this day). Explore the narrow, winding streets and many art galleries of this charming Greek village. Evening program: "Power and Faith."

Day 7 (Tuesday, 5/24) - Istanbul

Istanbul was home to Constantine the Great, who legitimized Christianity and began a time of relative freedom of religious practice in the Roman Empire. Istanbul later became the seat of the Byzantine Roman Empire. We will begin our day in the heart of the city, visiting the Blue Mosque, the remains of the Hippodrome, and Hagia Sophia, once the largest church in the world. This afternoon, we'll see the New Shalom Synagogue (Sephardic) and the Ahrida Synagogue (Built in 1453). We will visit the Jewish Museum of Turkey, before returning

Day 8 (Wednesday, 5/25) - Istanbul

We will enjoy a morning visit to the Chora Church, whose frescos and mosaics rival Hagia Sophia. We then travel to the Horn and Topkapi Palace, and learn about the sweeping changes in life and culture in the 15th century when the Byzantine Empire fell to the Ottoman Empire. Finish the afternoon with shopping in the Grand Bazaar.

Day 9 (Thursday, 5/26) - Ephesus

Today, we travel to the one-time seaport of Ephesus, probably the best-preserved ancient city in the Mediterranean. We will walk the ancient Roman streets where both Christian and Jewish communities existed and struggled for identity, acceptance, and integrity. Evidence of the Jewish community here includes a menorah on the steps of the Celsus Library. The Church of St. John is purported to be the burial place of the last surviving disciple.

Day 10 (Friday, 5/27) - Santorini

Once a part of the Mycenaean civilization, a horrific volcanic eruption blew the island apart and set back civilization for 100's of years. Today, it is one of the most dramatically beautiful places on the planet. Enjoy the view of the cliffs rising out of the sea from aboard ship or select one of the shore excursions offered by the cruise line (excursions not included on this day). We'll celebrate Shabbat that evening with dinner and Services.

Day 11 (Saturday, 5/28) - At Sea

Enjoy the day at sea as we sail west toward the setting sun. We'll be meeting together to discuss Jews and Christians in the Roman Empire. We will also offer Shabbat Services and Eucharist.


Day 12 (Sunday, 5/29) - Sicily

We will travel to Syracuse today to see the oldest preserved Mikvah in Europe, evidence of a once thriving Jewish community in Sicily. We will then visit the Syracuse Cathedral, whose walls were built around an existing Roman Temple, and we will have the opportunity to enjoy a bit of the beauty and vibrancy of modern Sicily.

Day 13 (Monday, 5/30) - At Sea

Join us at our farewell cocktail party and dinner at the Tuscan Grille to give thanks for and celebrate our time together!
