DAY 1 - SEATTLE, WASHINGTON Seattle is often characterized by its laid-back attitude and rainy climate, but this thriving metropolis also offers one-of-a-kind architecture, the Olympic and Cascade mountain ranges, and a unique urban sophistication. NOTICE: YOU MUST CHECK IN ATLEAST 2-3 HOURS BEFORE EMBARKMENT. Ship departs at 5:00pm.

#### DAY 3 - KETCHIKAN, ALASKA

Built out over the water and climbing weathered stairways, Ketchikan clings to the shores of Tongass Narrows and drapes the mountains with a cheerful air. Besides the main attractions - Creek Street, the Tongass Historical Museum, Totem Bight State Park and Saxman Village, try a optional flightseeing trip to breathtaking Misty Fjords National Monument.

DAY 4 - JUNEAU, ALASKA Juneau, the capital of Alaska, was founded during a gold rush in 1880. Today, the former gold-mining town counts among its riches some of Alaska's most spectacular scenery. Nestled at the foot of Mt. Juneau in the Alaska Panhandle, it faces the water from the mainland side of Gastineau Channel. Several magnificent fjords are located along the channel coast, and the majestic Mendenhall Glacier, a favorite of visitors, is nearby. DAY 5 - SKAGWAY, ALASKA When gold was discovered in the Klondike region of the Yukon Territory (just across the border from Alaska), it resulted in the historic Gold Rush of 1898. As thousands of gold-crazed adventurers sought the best starting point for their arduous trek, they found the deepest penetration possible by boat was at the northern tip of the Lynn Canal. This is how Skagway was born.

#### DAY 7 - VICTORIA, BRITISH COLUMBIA

Located on the southern tip on the island of Vancouver in British Columbia, the city of Victoria is probably best known for its mild climate and active outdoor lifestyle. (In fact, the city has been named the "fittest city" in Canada more than once.) As the capital of British Columbia, the city is very touristfriendly. Among the many attractions are world-famous gardens, its 150 years of British history, gourmet dining and fantastic shopping.


